MINISTER OF INDUSTRY CIRCULAR NO. 2 OF 2023 ON REPORTING OF EXHAUST GAS EMISSIONS WITHIN THE INDUSTRIAL SECTOR IN THE SPECIAL CAPITAL CITY REGION OF JAKARTA, WEST JAVA, AND BANTEN PROVINCE.

1. Background

Due to air pollution in Jakarta, West Java, and Banten lately, the Ministry of Industry (“**MOI**”) issued a Minister of Industry Circular No. 2 of 2023 on Reporting of Exhaust Gas Emissions Within the Industrial Sector in the Special Capital City Region of Jakarta, West Java, and Banten province (“**Circular**”).

In this case, Industrial Companies have an obligation to implement green industry and submit reports through the National Industrial Information System (“**SIINas**”) portal.

2. Reporting Requirements

- Industrial Companies in the Special Capital City Region of Jakarta, West Java Province, and Banten Province which in the process of energy generation, production process, and/or waste **emit** exhaust emissions and/or disturbances to the ambient air, are obliged to:
 - a) implement exhaust gas emission control;
 - b) ensure the fulfillment of exhaust emission parameters and ambient air in accordance with the provisions of laws and regulations; and
 - c) submit a periodic Exhaust Gas Emission Control Report every 1 (one) time in 1 (one) week, on Thursday through the SIINas portal (www.siinas.kemenperin.go.id).
- Exhaust Gas Emission Control Report for Industrial Companies at least contains:
 - a. Installation of emission control devices that are fit for operation;
 - b. Data on the officer in charge of air pollution control and the officer in charge of certified air emission control operations;
 - c. Procedures for handling and storing raw materials, fuel, and hazardous waste (“**B3 Waste**”), and/or non-B3 Waste resulting from combustion that has the potential to produce exhaust emissions;
 - d. The procedure for addressing air pollution emergency situations
 - e. Monitoring data at critical points generating exhaust gas emissions

- Verification of the Exhaust Gas Emission Control Report is carried out by an inspection team determined by the Minister of Industry, and Industrial Companies that do not carry out the obligations as mentioned above, will be subject to sanctions in accordance with the provisions of laws and regulations.

3. Report Mechanism

Industrial Companies report on exhaust emission control in the following ways:

- a) login through SIINas account;
- b) click on the "e-Reporting" menu;
- c) select "Emission Control Report";
- d) complete the form and upload the appropriate supporting documents; and
- e) click the "Submit" button to submit the report.

4. Validity Period of The Regulation

This Circular shall come into force on the date of issuance, namely from August 25, 2023 until December 31, 2023.
